### **Other Information and Frequently Asked Questions**

#### Q. What are my giving options?

A. Cash and in-kind donations of grain, stocks, or land. Cash and grain payments can be spread over three years, if desired.

#### Q. What is the difference between the places where my gift can be directed?

A. There are four places' gifts can be directly to:

- 1) ETA Alumni Corporation these gifts are **not** tax deductible, but immediately available for use for roof construction and mortgage. Gifts of grain are ideal for this purpose.
- 2) ETA Education Foundation these gifts are tax deductible; the foundation will loan funds to the corporation for use. 100% of these funds go to AGR.
- 3) ISU Foundation, directed to AGR's benefit these gifts are tax deductible, however 5% of the funds are paid to the ISU Foundation for administration and processing. Typically giving through the ISU Foundation counts towards total giving membership in the Order of the Knoll Campanile Society. Additionally, some corporate matching programs require you to give to a large foundation like ISU. If you are making a gift to AGR through Iowa State University, please include a note with the check and notation in the memo line as follows: "Account #0710741 Alpha Gamma Rho Education Foundation."
- 4) The Educational Foundation of Alpha Gamma Rho (National Fraternity) directed to the ETA Chapter through the Local Chapter Excellence Campaign. These gifts are tax deductible; the National Foundation will transfer funds to the ETA corporation for use. 100% of these funds go to AGR.

#### Q. How will recognition work?

A. We plan to have a Recognition Wall located in the lobby or foyer area of the house, with recognitions at different increments of giving. Note that if you do not wish to be recognized or wish to make it in honor of another party, please indicate that in the comments section on your pledge form.
